EVENT REMINDERS/EXPECTATIONS:

- We look forward to welcoming you onboard! Your feedback and participation during this event are essential and will prove invaluable.
- Credit Cards will be required to set up your onboard account. No cash accounts will be permitted.
- A health questionnaire must be completed via the app and will be available 24-hours prior to sailing.

REGISTRATION

- Invitations to register for this event are non-transferable.

DOCUMENTATION

- Each guest must present the following:
 - A valid Passport book or Passport card is strongly recommended to expedite the check-in process. Other government documents, such as U.S. birth certificate (state-issued) and valid government photo ID will be accepted if valid Passport is unattainable.
 - Hard-copy of vaccination card as proof of being fully vaccinated against COVID-19 using an FDA or WHO authorized vaccine.

ACCOMMODATIONS

- Each guest will be granted one double occupancy stateroom to invite a guest of his/her choice.
- **All individuals in attendance must be 18 years of age or older and fully vaccinated from COVID-19 at least 14 days prior to the sail date.**
- One guest in each stateroom must be at least 21 years of age.
- Staterooms will be assigned at random and cannot be preselected nor changed once confirmed

ONLINE CHECK-IN

- Reservation numbers will be provided to all volunteers once manifested. A system-generated invoice is automatically sent to the email address on record.
- Once in receipt of your assigned booking number, download the Royal Caribbean App to your mobile device and complete the online check-in process.
 - Royal Caribbean App check-in is available up until 8:00 a.m. on embarkation day
 - Arrival appointments are required and will be enforced; Be sure to select the best time for your traveling party.

BOARDING:

- Arrival appointments are required; During the online check-in process, be sure to select the best time for your traveling party.

PARKING

- Cruise Terminal 1: 9050 Discovery Rd, Port Canaveral, FL 32920; Parking is adjacent to the terminal
- \$17 per vehicle per day
- Accepted form of payment: Credit Card only

TERMINAL ARRIVAL

- **All guests are required to complete the Safety Briefing before the ship sails.** In the terminal using the app, please launch the Safety Briefing by tapping the safety icon on the homepage of the app. The app will guide you to complete the final step of the Safety Briefing upon boarding the ship at your Assembly Station.
- It's imperative that participants arrive at the terminal at the selected appointment time. No exceptions will be permitted.
- Luggage assistance at the terminal will not be available for this event.

DINING

- **BREAKFAST & LUNCH:** Windjammer Café is open on embarkation day between 11:30 a.m. - 3:00 p.m. on Deck 11.
- Breakfast will be available on debark day in the Main Dining Room between 6:30 a.m. - 8:00 a.m. and in the Windjammer between 6:30 a.m. - 9:00 a.m.
- **LUNCH:** Windjammer Café is open between 11:30 a.m. - 3:00 p.m. on Deck 11. Reservations are required via the Royal Caribbean App once onboard.

- Reservations are required via the Royal Caribbean App once onboard for both venues.
 - Windjammer Café will NOT be available for dinner.
- There will be limited opportunities to dine in specialty restaurants at a 50% discount.
- Specialty Dining reservations are required via the Royal Caribbean App. Social distancing will be in place.
- Room service will be available. Breakfast is complimentary and all-day menu will be available for extra charge.

VACCINATION AND TESTING

- You must be fully vaccinated to participate.
- **All volunteers participating in this event will need to take a COVID-19 test (PCR or antigen) with an accredited test provider, such as a drugstore chain or diagnostic lab, no more than 3 days before arriving at the terminal for embarkation. Proof of negative test result will be required to board the vessel.**
- Certain volunteers will be designated as “unvaccinated” to aid in simulating protocols for unvaccinated guests.

ONBOARD

- Safety Briefing: Upon joining the ship, please ensure you check into your assigned Assembly Station.
- Cruise Compass is available on the Royal app and printed copied available by request
- Beverages will be available to purchase at 50% off once onboard. Beverage packages will not be available.
- There will be no discounted rates for purchases made at Starbucks.
- An 18% gratuity will be applied to all food and beverage purchases.
- Dining, Entertainment & Activity reservations can be booked via the App once onboard.
- Shore excursions will be available to reserve at 50% off.
- VOOM Internet will be available at a 50% discount.
- Photo purchases available at a 50% discount for Printed Photos, Digitals and Retail (electronics excluded).
- Retail shops and Spa services will be available
- Customary Crown & Anchor Society benefits will not be available on this sailing, i.e. cruise ports, lounge access, exclusive Pinnacle events, etc.
